- Stephen: Polk 2
 - Housing for those aging out of foster care.

 - No compostable food storage, utensils, tea bags, coffee filters, or bags
 - Tips on how to keep it from getting the "ick factor"
 - Commercially composted

Questions:

- Katie: Can street sweepers come on days other than trash pick-up days?
- Look up materials processors can admit, such as they cannot admit a lot of the "compostable" take-out containers
- Thea: Is there a way to get compostable bins for apartments? Asked to email Mr. Zublin, as multi-family is tricky.
- Stephen: What's the current status of the pilot project to accept certain types of plastics? Called the Community Plastics Collection Program. Can be found on the Lane County Waste Management website or Facebook page. Plastics roundups w/ neighborhood leaders, where in the fall there were stand alone events at community centers.
- Sigh: Does Whiteaker have someone to run a collection site? Eco Generation was the non-profit spearheading that project along w/ Lane County Waste Management. Why can't processed plant fibers be composted? Ex/ cotton plant vs. spun cotton? Would have to follow up.
- Delenia: What are the "do's" for food. Screen was shared to answer question. Any food you can't or won't eat.

- Stephen: Clarify baked goods: even glazed, oily is ok? Fine. Big exclusions are papers, plastics, liquids, greased oil.
